EXCLUSIVE PROVIDER ORGANIZATION (EPO) UPDATE

Our EPO Nominations and Review Committee was asked to comment on the five (5) largest Orthopedic & Spinal surgery groups in the Twin Cities area to assess clinical services such as: timing (and delay) of scheduling procedures and follow-up appointments; ease in obtaining (and the clarity of) diagnostic results, treatment plans and work restrictions; and the use of narcotic medications during (and after) treatment.

Their feedback has and will continue to be used to resolve the service issues identified in order to achieve the UCWCP's MISSION: deliver the most appropriate treatment, as quickly as possible, from 'best in class' physicians in order to minimize the physical and financial impact of the injury to our participants.

MAP OF WORK INJURY TREATMENT CLINICS-COMING SOON

Near the end of April, all participating contractors will be mailed a hard-copy color map for the Twin Cities Metropolitan area listing 17 medical clinics that specialize in treating work injuries. This map is "UCWCP" branded, and is only for the use of our participating contractors.

AUDITORS AGAIN PROVIDE PROGRAM WITH THE HIGHEST LEVEL OPINION

Following the Trust Auditor's thorough review of the program's records the UCWCP, a 501 C (9) non-profit Labor-Management Trust, received the highest-level opinion on our audited financial statements.

DOING WHAT EVER IT TAKES TO AVOID LOST TIME [AND LESSEN E.M.R. INCREASES]

The program encourages all of our participating contractors to have a proactive program for making sure injured employees can return to light-duty work during their recovery. However, a few of our contractors' strategies stand out: bringing paper work to the injured workers' home; providing transportation to the light-duty job site; assigning a co-worker to assist with some physical tasks; assigning technical tasks (blue-print take-offs, estimating) with supervision; among other ideas.
