Alternative Dispute Resolution Services: Intervention

Do you have a question or concern about a workers' compensation claim?

Did you know the program provides informal assistance to resolve an issue or dispute between two parties?

Intervention assistance is available to participating contractors, union members, insurers and any legal representatives. A UCWCP staff person will assist in resolving the question or concern by contacting others involved as necessary. Most issues are resolved in this way. If intervention does not resolve the issue, we can look at other alternative dispute resolution services.

Here are examples of problems the UCWCP is able to resolve through intervention:

- Injury reporting and filing of a workers' compensation claim.
- Barriers to return to work and to pre-injury status.

- Requests for medical treatment and authorization.
- Seeking medical treatment from the appropriate medical provider.
