The Board of Trustees approved NO CHANGE to the formula for calculating employer contributions for this fiscal year, July 1, 2023 - June 30, 2024: 2022 calendar-year union payroll multiplied by .0012. Only payroll of employees who are members of participating unions is used for the calculation.

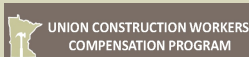
We wish you a fulfilling retirement!

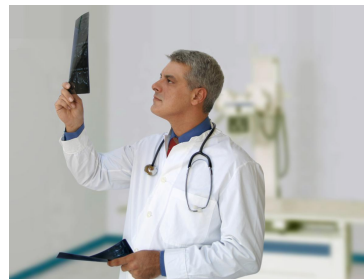
Exclusive Provider Organization (EPO) Updates:

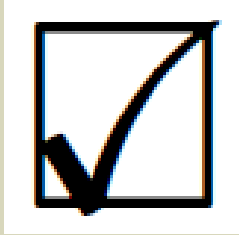

The UCWCP assesses the satisfaction of services provided to injured Union members, employer members, and claim administrators to ensure we are providing the best service possible. Surveys are sent following these activities:

Dispute Resolution Services: Following a Mediation, Arbitration or Dispute Resolution Exam, a survey will be sent to the injured Union member, employer and claim administrator requesting feedback on the overall process and services provided by the Mediator, Arbitrator or Neutral Physician.

Statutory Vocational Rehabilitation Services: Following the completion of statutory rehabilitation services, a survey will be sent to the injured Union member, employer, claim administrator and Qualified Rehabilitation Consultant requesting feedback on the services provided during the rehabilitation plan.

Survey results are review by the Program's labor-management Board of Trustees to ensure service outcomes align with the mission of the Program. We appreciate your feedback and assistance in providing the best service possible.
